EXERCISE OF PERSONAL DATA PROTECTION RIGHTS

(arts. 15-22 of Regulation (EU) 2016/679)

1. Access to personal data

(art. 15, paras. 1 and 3, of Regulation (EU) 2016/679)

 - the existence of automated decision-making processes, including profiling, and significant information about the logic used, as well as the importance and consequences of such processing for the data subject;
 - in the event of transfers to other countries or to an international organization, the existence of adequate guarantees regarding the transfer pursuant to art. 46.
